On 07/31/2022 at approximately 03:50 HRS this unit was dispatched code 3 to Lawrence and Delaware for a weapons call. Upon our arrival, we observed an extremely large group of people down occupying the block. Some individuals began to leave as crews arrived on scene with lights and sirens activated, however, the majority of the group remained. This unit and multiple others waited for unit 305 to arrive on scene before pushing down the block to clear the crowds from the streets, sidewalks, and yards. The crowds were repeatedly given numerous verbal commands to disperse.

While we were handling a belligerent, aggressive crowd at 2734 Lawrence AVE Toledo OH 43610, Clarence Trevon Jordan (S1) was taken into custody without incident or injury. During search incident to arrest, S1 stated that he had a bag of marijuana and approximately \$1100 cash in his pockets; both of which were located. S1 and his property was secured in our patrol vehicle. This unit contacted vice but we were unable to reach any detectives at the time.

While attempting to disperse another crowd that formed in the process of the incident, O'Shea Jones (S2) came up behind this unit and other crews, screaming, and failing to follow instructions. Orders to leave the area were given repeatedly, and continued to be ignored by S2 as she remained at the intersection of Lawrence and Wall, instead of returning to her home. S2 impeded the lawful duties of officers on scene, which posed a threat to crews still attempting to disperse the crowds. S2 was then taken into custody, but she began actively pulling away from Ofc. Pluff and Ofc. Missler. S2 was uncooperative, continuously turning, pulling her arms away, and turning to face Ofc. Pluff. Ofc. Pluff utilized verbal commands, joint manipulations on the arm, and head control to push S2's face away from her face to ensure officer safety from bodily fluids while affecting the arrest. Ofc. Missler was able to place the handcuffs on S2 while Ofc. Pluff secured her hands. S2 was escorted to 421's patrol car without further incident. No injuries were reported.

S1 was transported and booked into LCJ without any incident or injury, with the cash that was on his person at the time of his arrest. The sandwich bag of marijuana was booked into the Central night property room.
